2. The student is subject to the rules and regulations of Tasman School and the discipline provisions of the New Zealand Education Act 1989
3. They will provide the school with accurate and curent medical and academic information about the student.
4. Neccesary visa and permits required to study at Tasman School are valid.
5. While all care is taken, Tasman School does not accept any liability for any loss, damage or accidents that may occur. All students are required to have Travel and Medical insurance to cover themselves for any accident.
